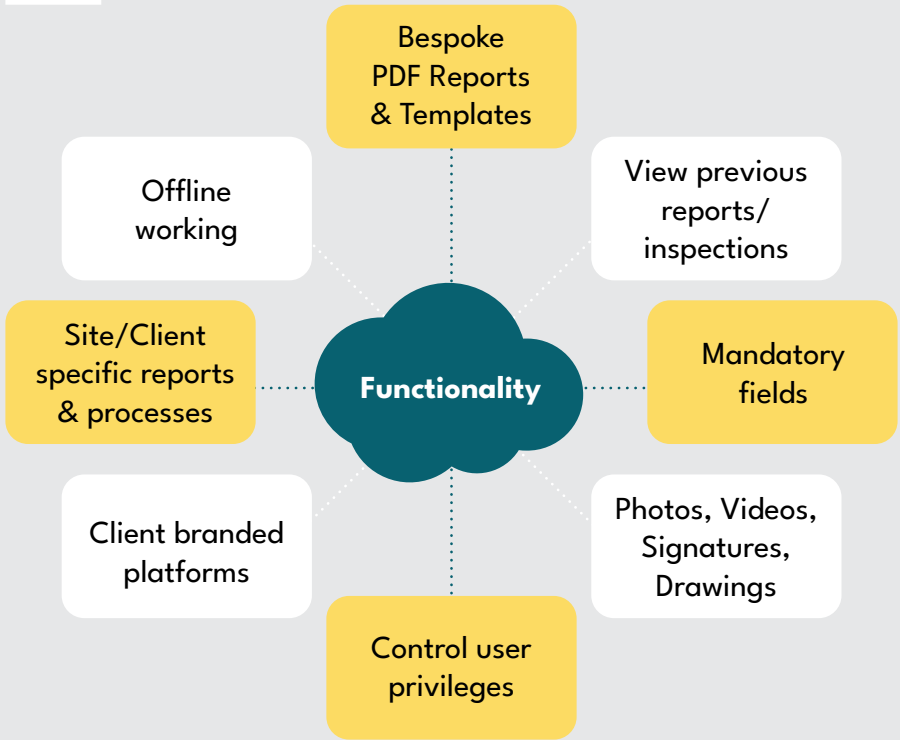

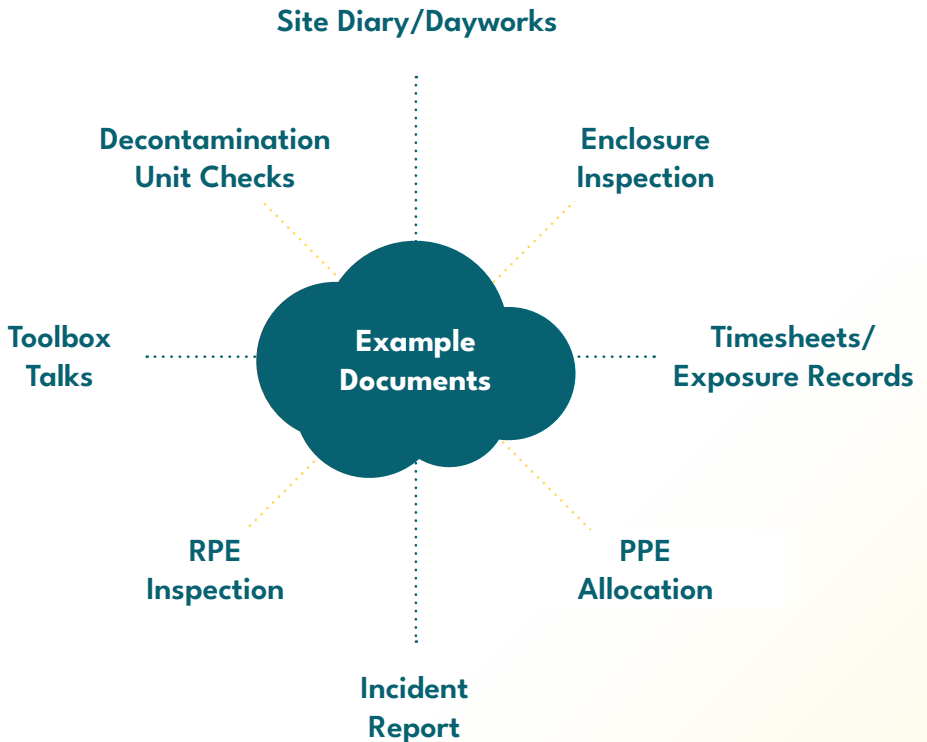
Some of the frequently used rules within scaffolding:

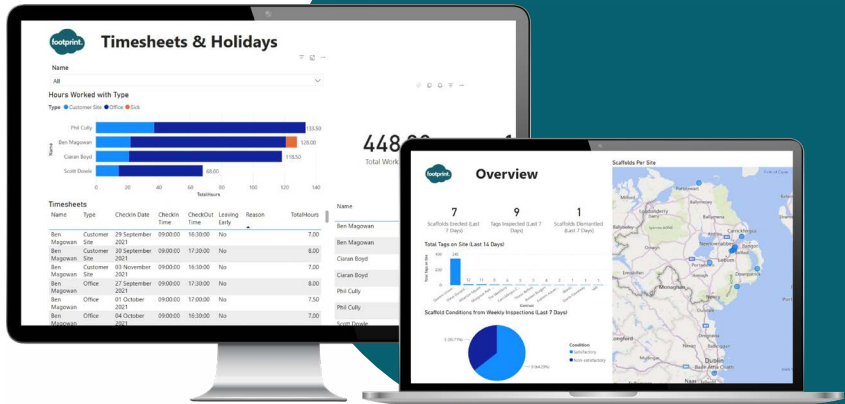


Grouping key business information

Example: Health and Safety
